5 Chair Report/Executive Committee – Pam Hrick (Chair of the Board)

5.1 2021-2022 Board Agenda Forecast

Pam Hrick referenced the updated 2021-2022 Board Agenda Forecast, including additions of staff presentations. This agenda forecast will continue to be updated as committees develop their annual workplans throughout 2022.

5.2 Letter to Request increase in core funding to the City of Toronto

 Pam Hrick asked Board members to review the Letter to Request increase in core funding to the City of Toronto and welcomed any questions.

5.3 Motion re: AOCC Board Members Vaccination Requirement

- Pam Hrick referenced the following motion to be considered at City Council later this week:
 - City Council require that any Member of Council who wishes to attend in person any City Council meeting, Committee meeting, tribunal meeting, or meeting of an City Agency, Board, or Corporation must provide proof of being fully vaccinated to the City Clerk prior to the meeting and that Members failing to do so will be required to participate remotely.
 - 2. City Council require that, where the City Clerk provides support to a tribunal, Agency, Board, Corporation or Council Advisory Body, any Public member who sits on these bodies and who wishes to attend a meeting in person, must provide proof of being fully vaccinated to the City Clerk prior to the meeting and that Public appointees who fail to do so will be required to participate remotely.
 - 3. Council request all Agencies, Boards, and Corporations that are separately governed to adopt this Policy. This motion would require city councillsors (including public agency city boards) to provide proof of vaccination to attend in-person meetings to the city clerk's office and requesting that the AOCC boards adopt a similar policy.
- Members of the Board raised concerns around the collection and retention of such personal health information, and further clarity for what constitutes a meeting in this context.

- Maura Lawless explained that staff have requested further clarity from City Legal, City Clerk's Office and the City Manager's Office, and that they would report to the Board once further information is shared.
- Tyler Johnson agreed to bring these concerns to the Councillor's attention, and indicated that their office is seeking similar clarity.
- Tyler Johnson also shared that the motion would go before Council on Thursday, December 16 in the afternoon.
